5 Matters arising not covered elsewhere on the agenda

- 5.1 ACTIONS ARISING FROM THE MEETING HELD ON WEDNESDAY NOVEMBER 14TH 2013
 - 1. Medical and Clinical Tasks Policy LH attended a meeting in Dec 12, there is currently no pilot running although Brunel have been using the letter and will provide feedback. Andrew Palk is contacting a practice to try to get a pilot running.
 - 2. EPS A combination of staff shortages and IT problems have meant the pilot stopped last August and is currently on hold. The next EPS meeting is at the beginning of February. The CCG are still keen to support roll-out in Somerset.
 - 3. Oxygen JH not present. Cheryl has some practice information, which will be brought to the next PAMM. GW will prepare the information.

- 4. East Mendip Joint Working Framework The last few clinics are occurring this month, HK will provide feedback next month.
- Depot Antipsychotics Raise at Partnership/LMC liason This has been raised and practices are assured that CPN support will continue if they take on prescribing responsibility. LH will provide data of which practices are participating in the LES for the next PAMM.
- 6. Continence Preferred Product List Share with secondary care This has been shared, a request has been made for PIP codes to be added. The prescribing data was viewed, HK asked for data to be provided for non-formulary prescribing. AB will share the list with the district nursing teams. SG said that there is national movement around appliance providers supplying products prior to receiving the prescription. A paper has been released suggesting that clean, non-coated re-usable catheters are the most cost effective option for intermittent self catheterisation, a pack of 5 lasts for one week.

- 5.2 Prescribing Audits/Incentive Scheme 2013/14

SG gave an overview of the aims of the incentive scheme due to the changes in QOF. SG will bring a draft scheme next month which will include meeting with the MM team and prescribing audits. Can all federation leads please feed back their views?

It was proposed to drop the ARB, Opiate and Antipsychotic in Dementia indicators and keep the Statins and generic savings indicators – all agreed.

Possible new indicators Venlafaxine MR to plain with a target of 30-40% compliance and plain Oxybutynin or Tolterodine as a percentage of all urinary incontinence drugs also with a target of 30-40%. Can all federation leads and GPs feedback views and ideas for the next meeting.

5.5 Specials Guidance (SPCT v2.1 January 2013)

The new version was viewed, to be shared with federations and should already be available on the navigator app.

5.6 Insulin Initiation Audit

Data from MPH was viewed last meeting. There has still been no data produced from the community diabetic service. AB will chase with Su Down. SG will copy AB into the previous correspondence.

5.7 Phenytoin

This has been discussed amongst senior CCG leads. A suggestion has been made that other Flynn products could be black listed – this is not supported by the PCT. Locally, a document has been produced to give options for practices who wish to review their current Phenytoin patients – particularly those taking Phenytoin but are still having fits. GS will redraft and bring to the next PAMM.

6 Other Items for Discussion

6.1 Boots Managed Repeat SOP

SG gave an overview of managed repeat systems and recommends that PAMM support the Boots SOP as this now follows PCT guidance. HK requested that the SOP includes a step for pharmacists to inform the patients GP if an item is not dispensed, SG will feed this back but there are issues around patient confidentiality. GS asked for a reminder of batch prescribing to be in the newsletter.

6.2 Prescribing Leads Meetings 2013

Agreed to hold in May and November as before, LH will contact JH.

6.3 Meningococcal Prophylaxis Draft Dec 2012

This is a change of SOP, now using Ciprofloxacin 1st line for prophylaxis of close contacts, item in the newsletter please.

6.4 2014-15 NICE QOF Indicator Consultation Document

This was shown to make PAMM aware of potential areas to come – noted.

6.5 2013 Draft Policy Working With the Pharmaceutical Industry and rebate policies

Rebate Policy – SG met with CCG and Director of Finance, COG has asked for more governance, it has now been re-drafted and will go to the CCG board in February, it will hopefully be in use for 1st April 2013. Can all federation leads feedback comments.

Working with the pharmaceutical Industry – SG explained that this is adapted from the national document. There is a separate guide for hospitality and sponsorship. The policy is for use by CCG officers who should keep a register of all meetings with pharmaceutical companies if it is related to their role in the CCG, there will be separate guidance for federations and practices as these are independent contractors and will be on the agenda for the prescribing leads away day. It was agreed all federation leads should feedback information of joint working projects to PAMM.

6.6 Quality Premium 2013/14 Guidance for CCGs

This was published in December and defines areas of service CCGs will be monitored on by the National Commissioning Board. The medicines management team can help with preventing admissions, mortality and infections. This will be discussed at COG in the future.

6.7 Continence Appliance Reference Guides Discussed above under review of actions.

6.8 Somerset Prescribing Forum

Viewed the agenda. There was a discussion around Apixaban and the need to update the guidance to include it. Other issues were discussed including the licence for use of Strontium in men and Desunin which may be an alternative to Fultium D3 for patients who cannot take capsules.

Taunton and Somerset Anti-microbial Prescribing Group – Have been working on the policy for cellulitis, Lucy Watson is leading on this, have also been discussing Meningococcal prophylaxis.

YDH D&TC – Meeting next Monday, will raise incontinence appliances, LH will send the forms to Steph to be added to the agenda.

BANES/RUH D&TC – nothing to report.

BCAP – nothing to report.

LMC/PCT/CCG Liaison – Met to discuss the DMARD spec for the LES which should hopefully be approved soon.

LPC – EHC has been re-launched but the MAS is still not ready. Smoking cessation will be looked at to improve the service including targeting patients requesting NRT over the counter. The Asthma/COPD MUR plus is now being piloted.

LPN – viewed the agenda. MT gave an overview of the LPN for the new PAMM members.

CD LIN – Have been debating clinical concerns of legal highs. Currently waiting to hear the outcome of the national consultation for the position of the accountable officer.
